## Boarding Agreement

This Agreement is made between The Happy Dog Inn (HDI) and the Owner of the Pets(s) listed below and shall govern all stays at HDI.

### **Boarding Care of Pet(s):**

HDI agrees to provide reasonable care at all times, a sanitary shelter, the feeding, exercise, comfort, play and living environment as explained on the HDI web site ([www.thehappydoginn.com](http://www.thehappydoginn.com)). Owner acknowledges reading the web site description under "Rates, Hours and Things to Know" tab, and acknowledges inspection of HDI and that the conditions are acceptable. Special care instructions shall be provided by Owner in writing and accepted, or not, by HDI before the first drop off. HDI reserves the right to refuse service.

### **Fees, Charges:**

Owner agrees to pay \$50.00 for a single pet, and \$25.00 for each additional pet in the same suite per day and one half these amounts for ½ days. Owner shall make full payment for boarding services in the event of early pick up of Pet(s). Owner agrees to pay a 3 day fee if cancellation is less than 3 complete days prior to scheduled arrival. (Exception; Christmas and Thanksgiving Holidays are confirmed 30 days in advance and are non-cancelable). For recurring services, Owner agrees to maintain current credit information with HDI. Stays may be extended in event of Owner emergency, but only if HDI agrees and has space available, and Owners procures HDI telephone agreement. If pick-up is on a date later than agreed, Owner agrees to pay for all days at the rates stated. For all fees and charges incurred under this agreement, Owner authorizes HDI to charge Owner's credit card upon the date agreed for pick-up and thereafter as incurred. Rates are subject to change, Owner will be advised of any change prior to drop off. Owner will be responsible for all legal fees incurred by HDI in its effort to enforce this agreement. Effective June 1<sup>st</sup>, 2012 all rates will increase by \$5.00 per night per dog.

### **Food, Medicine:**

Owner agrees to provide enough food and medicine for Pet(s) for each day of Boarding, plus two extra days, as well as any medication with written instructions for use at time of drop off.

In insect season, pet(s) will be treated with a flea and tick control product if they are not currently on a flea and tick program. There is a onetime charge per stay of \$10.00 per dog.

If an emergency does arise requiring veterinary care for Pet, care will be provided by HDI choice of veterinary hospital, pet insurance information must be supplied for every stay. Owner authorizes the **circled** maximum amount to be charged on Owner's credit card for medical care without further Owner consent:

HDI will notify Owner of the emergency as soon as reasonably possible (with deference given to the urgency required for treatment of Pet) at the contact information provided. HDI will not authorize medical services above the amount circled above, { EX: if you circle \$1,000.00 and it takes \$1100.00 to keep your dog alive, we will decline medical care}. Owner agrees to then take over all arrangements for the care and payment with the vet.

**Owner agrees to keep all credit card and contact information current.**

Minor medical problems as determined by HDI such as ear infections, cut pads etc, do not require veterinary care unless life threatening and will wait for owners return.

**Play Group Authorization and Release:**

Owner would like Pet(s) \_\_\_\_\_ to be allowed in playgroups. Owner understands and acknowledges that there is always the possibility of injury to Pet either to itself or by another dog, and that dogs may be unpredictable. Owner hereby releases from any and all liability HDI (and all of its care providers, owners, officers and employees) for any injury to Pets associated with being in a playgroup.

**Limitation of HDI:**

The maximum liability of HDI for any failure to perform hereunder or for any harm, other than intentional and willful, to Pet(s) for any situation shall be the cost of the stay during which the harm may have occurred, but not to exceed \$500.00. There shall be no liability for acts of nature, ingestion of foreign objects, insect infestation or bites, contact with wildlife, lightening or other Acts of God. Abandonment of Pet: The provisions of Arizona Revised Statues 3-1310., shall apply.
